

1. Trustee Mario Pascucci: Is it possible to have a report of which schools have the new digital signs?

Associate Director Del Bianco: We will provide an update in Issues and Events.

2. Trustee Mario Pascucci: Can you provide a status of decisions made regarding September start up?

Director Mazzorato: Council of Ontario Directors of Education (CODE) has impressen(f, )-3(a)5(n)4(d)4(b)1an

Director Mazzorato: We are staffing according to class size regulations, which is different from what is presently in place. Physical distancing creates lower class sizes. This may mean another summer of preparing multiple scenarios.

8. Trustee Stefano Pascucci: Can you explain what occurs if a parent/guardian has advised that we cannot use photos of their child(ren)?

Director Mazzorato: Each September parents/guardians are sent a waiver to give permission for their child(ren) to be photographed. If a parent/guardian does not sign the waiver, it is our responsibility to ensure that images of the child(ren) are not used in print or video, including group projects.

9. Trustee Anna Da Silva: Please clarify what exactly the situation will be if secondary students begin in Quadmesters?

Director Mazzorato: Similar to the model used in September 2020, secondary classes will be organized in a Quadmester delivery model (i.e., two courses per ten-week cycle) for at least the first semester of school until the end of January. We will prepare with the ability to switch to semester for the remainder of the year, depending on the pandemic. We will not have definitive plans by the end of June. As we get closer to September, we will solidify our plans as directed by the Ministry. We are going to work with a hybrid model in secondary and will not be providing a remote only option.

10. Trustee Anna da Silva: Can you provide the name of the school that Emily Viegas, the child who passed away attended? Are there any plans to assist that school? I am concerned for the young people that are working at home remotely and may need assistance.

Director Mazzorato: Respecting the privacy of our staff and students we can tell you that the media has widely communicated that Emily attended St. John Henry Newman CES. We have provided support from our Social Work Department and the Tragic Events Response Team (TERT). A letter has been distributed to the school community which offered support for students that may need assistance dealing with the sudden loss.

Trustee Shawn Xaviour: I would like to commend Superintendent Les Storey, Principal Maria Castro, Vice Principal Elizabete Branco-Comparone and the entire staff of St. John Henry Newman CES for the hard work and dedication to ensure that support is in place for the school community regarding the sudden loss of Emily Viegas. My thoughts and prayers go out to her family and the school community.

11. Trustee Mario Pascucci: Can we have a status update on teacher absenteeism?

Superintendent Strong: I can share that our absenteeism has improved. Our teachers are pleased to work remote at home. The barrier of concern regarding working in schools when there is/was a COVID-19 case or break-out has been removed.

The committee also discussed opportunities to promote the Secondary School Scholarships and Awards Fund and potential fundraising ideas. One quick and easy solution was to ensure the Donations module within the Schoolcash.net system could accept donations for the Award Fund. Financial Services staff worked with the vendor to make changes to the module that includes a drop-down option to support Secondary School Scholarships and Awards within DPCDSB. The links to access the Donations module were also added back to the main DPCDSB website as well as the school websites.

The Financial Systems Support team are in constant contact with school office administration teams. They will ensure school staff are aware of the updated information, continue to train school staff and make sure schools are sharing information with families/communities regarding the **Make A Donation** option.

With regard to the discussion on promoting donations, it was noted that operating during the COVID-19 pandemic has been a difficult time for many families, thus, not an ideal time to heavily promote fundraising or donations. Options for advertising the Secondary School Scholarships and Awards Fund will be reviewed again in the next year and remain on the Secondary School Scholarships and Awards Committee agendas.

The Joe Hugel award will be discontinued after this 2020-2021 year. This recommendation was approved by the Board of Trustees last year. The remaining funds will be used to prolong the ability of the award fund to support the Edward King Memorial Award and the Thomas J. Reilly Scholarship for Grade 12 graduating students.
